

# Privacy Policy

## Cookies

A 'cookie' is a small amount of data, which often includes an anonymous unique identifier that is sent to your browser from a web server and stored on your computer's hard drive. Cookies do not damage your computer. Each website can send its own cookie to your browser if your browser's preferences allow it, but (to protect your privacy) your browser only permits a website to access the cookies it has already sent to you, not the cookies sent to you by other sites. The information gathered through the use of cookies, allows Scottish Leather Group Ltd to offer a quality Internet service and easily accessible online content to our users and catalogue traffic patterns throughout the website in a manner that provides personal privacy protection. We also keep track of your IP address to gather broad demographic information about you, such as your location and your Internet Service Provider. Scottish Leather Group Ltd may also collect aggregate information on how our users are utilising the site. This might include information regarding traffic patterns through the site.
